



## 2022-2023 Oil Pre Buy Program

A new heating season is approaching, and you can now be guaranteed a price per gallon. For the 2022-2023 heating season, Haffner's is offering an Oil Pre Buy Program.

**Effective period for Oil deliveries:**

**Monday, August 1, 2022 – Friday, April 28, 2023**

**Sign-up Deadline: Friday, September 30, 2022**

**Payment Deadline: With signed contract by Friday, September 30, 2022**

\*\*\*\* By signing this contract, you agree to pre-purchase your gallons for the heating season. These gallons will only be delivered between August 1, 2022 and April 28, 2023. Any gallons left over after April 28, 2023 will remain credited in an amount equal to the price you paid per gallon multiplied by the number of unused gallons. **YOU WILL NOT RECEIVE A CASH/CHECK/CREDIT CARD REFUND FOR ANY UNUSED GALLONS.** Credits may be used for future Propane/Oil related purchases only. Any such purchase will be at the daily posted price at the time of the delivery or service. If you use more gallons than you purchased under this Agreement, you will be required to pay the current daily posted price at the time of delivery for such gallons. \*\*\*\*

PROGRAM AVAILABILITY is **LIMITED** and **SUBJECT TO APPROVAL.**

IT IS A **FIRST COME, FIRST SERVE** BASIS – Contract is not valid until payment is received in full.

**Pre Buy Plan – 250 gallons or more: \$4.399 per gallon**

IF OIL PRICES CHANGE AFTER YOU SIGN THIS AGREEMENT, YOU WILL NOT BE ENTITLED TO ANY REFUND OR CREDIT.

This Agreement must be signed by the customer and submitted to us with payment in full. In order to be eligible to participate in our 2022-2023 Oil Pre Buy Program (1) you must be enrolled in automatic delivery with us for the entire contract period unless other arrangements are made with our company prior to submission of this form. (2) Any deliveries outside of the pre-purchased gallons will be your responsibility to pay in full at our daily posted price. (3) You must either have a zero balance or a credit balance with us prior to acceptance into this program. (4) Your tank(s) and piping must pass an inspection if you have not received a delivery from Haffner's within 12 months prior to the submission of this contract. **ENROLLMENT IN AUTOMATIC DELIVERY WILL END ON APRIL 28, 2023. IF YOU WANT TO CONTINUE AUTOMATIC DELIVERY AFTER APRIL 28, 2023, PAYMENT ARRANGEMENTS MUST BE SET UP BY CONTACTING OUR OFFICE. FAILURE TO DO SO WILL CAUSE YOUR ACCOUNT TO REVERT TO "WILL CALL" DELIVERY STATUS, WHICH REQUIRES YOU TO CALL US TO SCHEDULE AND TO PLACE YOUR FUTURE ORDERS UNDER COD PAYMENT TERMS.** You do not have the right to assign this Agreement without our prior written consent.

**Haffner's shall not be obligated to perform under this contract if prevented by any local, state or federal regulations governing any energy crisis or other events beyond their control, which may interrupt, limit or halt the supply of heating oils or propane.**
