



**2024-2025 Kerosene Price Protection Budget Program Agreement - Worksheet**

This 2024-2025 Kerosene Price Protection Budget Program Agreement (the "Agreement") is made by and between Energy North Incorporated d/b/a Haffner's Energy ("Haffner's" or "us") and \_\_\_\_\_ ("Customer" or "you").

A new heating season is approaching, and you can now be guaranteed not to pay more than the capped price per gallon, while also receiving full downside price protection. For the 2024-2025 heating season, Haffner's is offering a Kerosene Price Protection Budget Program.

Sign-up Deadline: Friday, September 13, 2024**

**CAP/Downside Protection Fee Payment Deadline:** With signed Agreement by **Friday September 13, 2024**

PROGRAM AVAILABILITY is **LIMITED, ON A FIRST COME FIRST SERVE BASIS,** and **SUBJECT TO APPROVAL.**

The Agreement is not valid until payment is received in full.

**Kerosene Budget CAP Plan** – 400 gallons or more: \$4.999 CAP price per gallon

**Required Non-Refundable CAP/Downside Protection - Fee-** \$0.25 per gallon non-refundable fee (if our posted cash price is less than our fixed price, you will receive the lower price)

## **2024-2025 Kerosene Price Protection Budget Program Agreement - TERMS**

1. **This Agreement must be signed by the Customer and submitted to Haffner's with the NON-REFUNDABLE CAP/Downside Protection Fee payment in full no later than Friday, September 13, 2024 to lock in your gallons and pricing. If Kerosene prices change after you sign and Haffner's receives this Agreement, you will not be entitled to any refund or credit.** The term of this Agreement shall be from the date Haffner's has accepted this Agreement through April 25, 2025, or when the number of gallons Customer has agreed to purchase under this Agreement have been depleted, whichever comes first.
2. Customer must have established credit terms with Haffner's and must be enrolled in automatic delivery with us for the entire Agreement period (unless other arrangements are made with our company prior to submission of this Agreement). **UPON SIGNING, CUSTOMER AGREES TO BECOME AN AUTOMATIC DELIVERY CUSTOMER AND REMAIN ONE THROUGHOUT THE TERM OF THIS AGREEMENT. If you select "No" on the following form when asked if you wish to remain on automatic delivery after the end of this Agreement, the final delivery of this Agreement may be a fill up regardless of the number of gallons remaining under the Program. Any balance in excess of credit under this Agreement, if any, will be payable within seven (7) days of the delivery.**
3. Customer must either have a zero balance or a credit balance with us prior to acceptance into this Program.
4. This Agreement is for the purchase of Kerosene product only and does not include the cost of any services.
5. Customer's tank(s) and piping must pass an inspection if you have not received a delivery from Haffner's within twelve months prior to the submission of this Agreement.
6. Monthly Budget Payments will be due on the 10th of each month. Last Payment will be due April 10th, 2025. The Number and Amount of Monthly Budget Payments will be calculated based on date Customer is accepted into the Program by Haffner's. **IF YOU FALL MORE THAN ONE (1) BUDGET PAYMENT BEHIND, YOU WILL LOSE CAP/DOWNSIDE PROTECTION BENEFITS, AND WILL NOT BE ENTITLED TO A REFUND OF ANY CAP/DOWNSIDE PROTECTION FEE PAID.**
7. Customer shall only purchase Kerosene from Haffner's during the term of this Agreement. **CUSTOMER WILL NOT RECEIVE A CASH/CHECK/CREDIT CARD REFUND FOR ANY UNUSED/UNPURCHASED GALLONS if Customer did not take delivery of the total number of gallons Customer agreed to purchase under this Agreement.** Customer will receive a Credit(s) to Customer's account which may be used for future kerosene purchases and related services only. Any such purchase will be at the current daily posted price at the time of the delivery or service. Additionally, if you use more gallons than you agreed to purchase under this Agreement, you will be required to pay the current daily posted price at the time of delivery for such gallons.
8. Customer does not have the right to assign this Agreement without our prior written consent.
9. **Haffner's shall not be obligated to perform under this Agreement if prevented by any local, state or federal regulations governing any energy crisis or other events beyond their control, which may interrupt, limit or halt the supply of heating fuels.**
10. **Seller Disclosure Applicable to New Hampshire Residents:** Haffner's has secured this Agreement and contracted gallons through its supplier agreements and/or liquid product inventory in accordance with NH RSA §339:79.
11. **Seller Disclosure Applicable to Maine Residents:** Haffner's has secured this Agreement and contracted gallons through its supplier agreements in accordance with 10 M.R.S.A §1110.

This Agreement will not become effective until accepted by Haffner’s.
