



## **2024-2025 Propane Pre-Buy Fixed Price Plan - Worksheet**

This 2024-2025 Propane Pre-Buy Fixed Price Plan Agreement (the "Agreement") is made by and between Energy North Incorporated d/b/a Haffner's Energy ("Haffner's" or "us") and \_\_\_\_\_ (the "Customer" or "you"). (Customer Name)

A new heating season is approaching, and you can now be guaranteed a price per gallon. For the 2024-2025 heating season, Haffner's is offering a Propane Pre-Buy Fixed Price Plan (the "Program").

**Effective period for Propane deliveries:  
Monday, July 1, 2024 – Friday, April 25, 2025  
Sign-up Deadline: Friday, September 13, 2024**

**Payment Deadline:** With signed Agreement by **Friday, September 13, 2024**

PROGRAM AVAILABILITY is **LIMITED** and **SUBJECT TO APPROVAL**.  
IT IS A **FIRST COME FIRST SERVE** BASIS – Agreement is not valid until payment received in full and approved.

**Pre Buy Plan 1: 1,200 gallons or more: \$2.599 per gallon**

**Pre Buy Plan 2: 700 gallons – 1199 gallons: \$2.799 per gallon**

**Pre Buy Plan 3: 250 gallons – 699 gallons: \$2.999 per gallon**

IF PROPANE PRICES CHANGE AFTER YOU SIGN AND HAFFNER'S RECEIVES THIS AGREEMENT YOU WILL NOT BE ENTITLED TO ANY REFUND OR CREDIT.

## **2024-2025 Propane Pre-Buy Fixed Price Plan - Terms**

1. **This Agreement must be signed by the Customer and submitted to Haffner's with the total payment for gallons to be pre-purchased under this Agreement in full no later than Friday, September 13, 2024 to lock in the gallons and pricing. If Propane Prices change after you sign and Haffner's receives this Agreement, you will not be entitled to any refund or credit.** The term of this Agreement shall be from the date Haffner's has accepted this Agreement through April 25, 2025 or when the number of pre-purchased gallons have been depleted; whichever comes first.
2. Customer must have a separate, current Customer Agreement in place with Haffner's and must be enrolled in automatic delivery with Haffner's (unless other arrangements are made with our company prior to submission of this Agreement). **UPON SIGNING, CUSTOMER AGREES TO BECOME AN AUTOMATIC DELIVERY CUSTOMER AND REMAIN ONE THROUGHOUT THE TERM OF THIS AGREEMENT. If you select "No" on the following form when asked if you wish to remain on automatic delivery after the end of this Agreement, the final delivery of this Agreement may be a fill up regardless of the number of gallons remaining under the Pre-Buy Fixed Price Plan. Any balance in excess of credit under this Agreement, if any, will be payable within seven (7) days of the delivery.**
3. Customer must either have a zero balance or a credit balance with Haffner's prior to acceptance into this Program.
4. Customer shall only purchase propane from Haffner's. **CUSTOMER WILL NOT RECEIVE A CASH/CHECK/CREDIT CARD REFUND FOR ANY UNUSED GALLONS if Customer did not take delivery of the total number of gallons Customer pre-purchased under this Agreement by April 25, 2025. Customer will receive a Credit(s) to Customer's account for any pre-purchased gallons not delivered by April 25, 2025 in the amount equal to the price paid per gallon multiplied by the number of unused pre-purchased gallons, which credit(s) may be used for future propane or service purchases only.** Any such purchase will be at the current daily posted price at the time of the delivery or service. Additionally, if Customer uses more gallons than Customer pre-purchased under this Agreement, Customer will be required to pay the current daily posted price at the time of delivery for such gallons.
5. This Agreement is for the purchase of propane product only and does not include the cost of any services. Prepaid amounts will not bear interest.
6. Customer does not have the right to assign this Agreement without Haffner's prior written consent.
7. **Haffner's shall not be obligated to perform under this Agreement if prevented by any local, state or federal regulations governing any energy crisis or other events beyond their control, which may interrupt, limit or halt the supply of propane.**
8. **Seller Disclosure Applicable to New Hampshire Residents:** Haffner's has secured this Agreement and contracted gallons through its supplier agreements and/or liquid product inventory in accordance with NH RSA §339:79.
9. **Seller Disclosure Applicable to Maine Residents:** Haffner's has secured this Agreement and contracted gallons through its supplier agreements in accordance with 10 M.R.S.A §1110.
